## Notice of Affiliation for the Academic Session 2024-25

- 1. Applications are invited from Private Educational Institutions situated within territorial jurisdiction i.e. whole of Punjab Province and out of the territorial jurisdiction (Islamabad Capital Territory) & (Law Colleges can apply only from all Districts of Bahawalpur Division) of the Islamia University of Bahawalpur for the grant / renewal of affiliation with this University for the Academic Session 2024-2025. The Institutions may apply through online application form available at IUB website: <a href="https://affiliation.iub.edu.pk/portal">https://affiliation.iub.edu.pk/portal</a>. The hard copy of the same is also required to be forwarded through the Director of Education (Colleges), Bahawalpur Division, Bahawalpur to the Registrar, the Islamia University of Bahawalpur.
- 2. Applications complete in all respect must reach the Registrar's Office on or before 30<sup>th</sup> May, 2024 along-with non-refundable application processing fee of Rs. 20,000/- per program for the colleges operating within the territorial jurisdiction of IUB i.e. Punjab Province, Rs. 30,000/- per program for out of territorial jurisdiction colleges (except law colleges) i.e. other than Punjab Province, Rs.150,000/- for all Nursing Colleges. The fee may be deposited in the Freedom Account No.00427900166703 of IUB through Online Bank Challan, generated from Online Affiliation Portal. The applications received after 30<sup>th</sup> May, 2024 and upto 17<sup>th</sup> June, 2024, will be processed on payment of above mentioned fees plus late fee of Rs. 20,000/-

## Please Note:-

- The college administration must fulfill the criteria for affiliation as prescribed by University.
- ii. The Institutions must be registered with the Education Department, Government of the Punjab for the session **2024-2025.**
- iii. The Institutions (except law colleges) falling within the territorial jurisdiction of another university shall submit their application alongwith the following documents:
  - a) NOC from the university concerned.
  - b) Sanction from the Govt. of the Punjab, Higher Education Department, Lahore.
  - c) The institutions (except law colleges) falling within the territorial jurisdiction of Islamabad, Capital Territory, shall submit their application alongwith NOC from the Higher Education Commission (HEC), Islamabad.
- iv. Incomplete applications or applications received without original copy of the Challan will not be entertained.

**NOTE:** The newly affiliated institutes / the institutes, which have not deposited these dues last year, shall have to deposit an endowment fund of Rs.200,000/- (Once per College in case of permanent affiliation) and security deposit of Rs.100,000/- (Once per college except Nursing Colleges) and security deposit of Rs.500,000/- (Once per college for Nursing Colleges only), only after grant of affiliation, in the IUB Account No. **00427900166703** as approved by the University Syndicate.
