- e. The 03 highest bidders shall remain shortlisted on reserve. If the highest bidder fails to perform, the second highest bidder shall replace him, similarly if second bidder fails to perform well, the 3<sup>rd</sup> bidder shall be given the opportunity to prove his potential.
- f. The highest bidder shall be awarded the contract initially for a period of three years, with two years of further extension, subject to the performance evaluation of contractor by the Committee with 10% of increase in rent each year.
- g. The successful Bidder's Call Deposit shall stand added to the Security Deposit whereas the Demand Draft/CDRs of the second and third highest Bidders shall be kept as backup candidates for minimum period of one month.
- h. No present or past contractor defaulter of any outstanding dues of the University shall be allowed to enter the Auction. He/she shall stand blacklisted for all future contracts with IUB. The contractors in legal suit with the IUB will not be allowed to participate in open bid/auction.

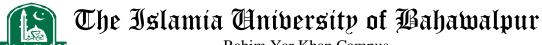

- i. I have been informed about the potential strength of students/visitors and I am aware that the mentioned strength is merely an approximation and does not bind any student/visitor to purchase exclusively from the outlet.
- ii. I have been informed that university will provide area for kitchen and the service area for students and staff will be developed by myself.
- iii. I agree that if I do not fulfill the mandatory requirements as mentioned in the tender documents, I shall not claim any right to enter the auction.
- iv. In case, I fulfill the requirements to enter the auction, I will appear in person or through the attorney (duly bearing letter of attorney).
- v. If successful in obtaining the score required to enter the auction process, I shall submit a Demand Draft/CDR in the name of Treasurer, IUB as security Deposit (refundable if bid is unsuccessful) to enter the bidding process as per schedule in the tender documents.
- vi. In case of winning the bid, I shall be bound to submit advance rent of six months within 7 days; failure to which; the Committee shall have the right to award the contract to the second highest bidder and my Guarantee Deposit shall be confiscated.
- vii. I agree to pay the rent Bi-annually e.g. advance rent of 6 months within 7 days of auction and next submission before 15<sup>th</sup> of every 6<sup>th</sup> month.
- viii. I also agree to pay the monthly electricity and other utilities bills on time as per actual.
- ix. I agree to file annual income tax return.
- x. I agree that the Punjab Government has levied 22% tax (in case of non-filers) and 11% (in case of filer) on services. I shall be bound to pay as per given schedule.
